What is the purpose of this update?

This document tells you how the New Zealand Fixed Interest Fund (Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. 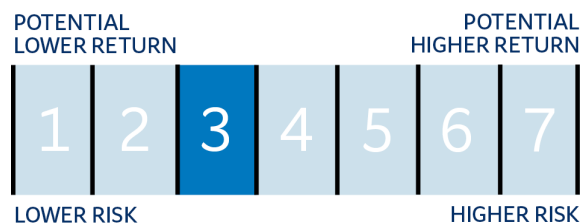
Description of this Fund

The New Zealand Fixed Interest Fund invests mainly in New Zealand fixed interest securities, primarily investment-grade government and corporate bonds, with the ability to gain exposure to a lesser extent to Australian and United States fixed interest markets. It aims to provide a gross return in excess of its benchmark index, over the medium term.

What are the risks of investing?

Risk indicator for the New Zealand Fixed Interest Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down (volatility). A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

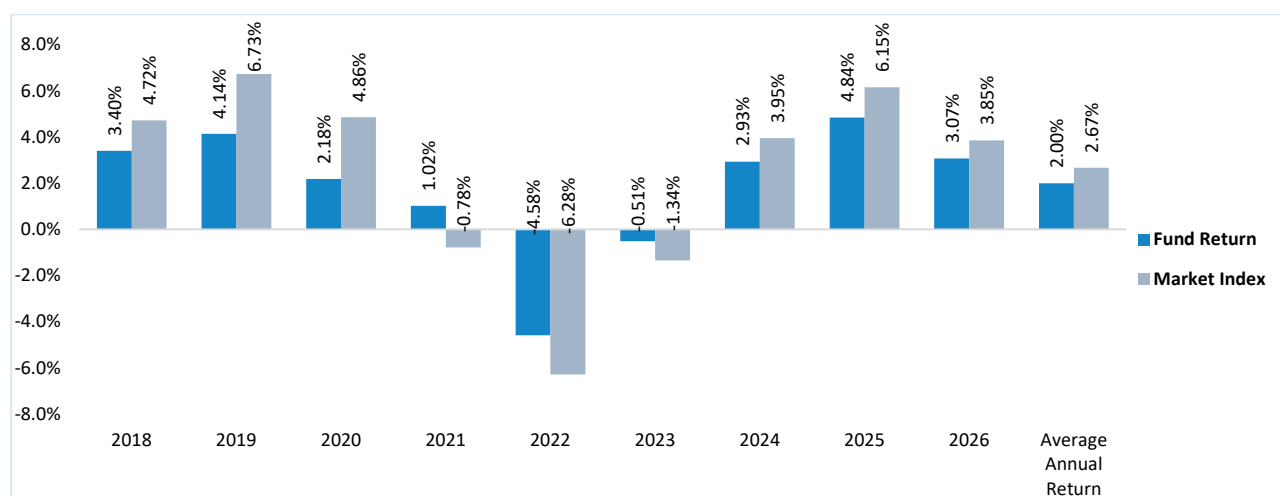

How has the Fund performed?

The graph shows the return after Fund charges and tax for each year ending 31 March since the Fund started. The last bar shows the average annual return since the Fund started, up to 30 June 2026.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

John had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, John received a return after Fund charges were deducted of \$408.00 (that is 4.08% of his initial \$10,000). John also paid \$0.00 in other charges. This gives John a total return of \$408.00 for the year.

What fees are investors charged?

Investors in the New Zealand Fixed Interest Fund are charged Fund charges. In the year to 31 March 2026 these were (excluding GST):

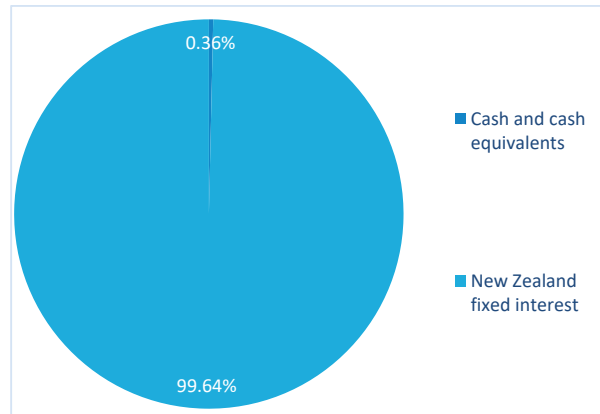

What does the Fund invest in?

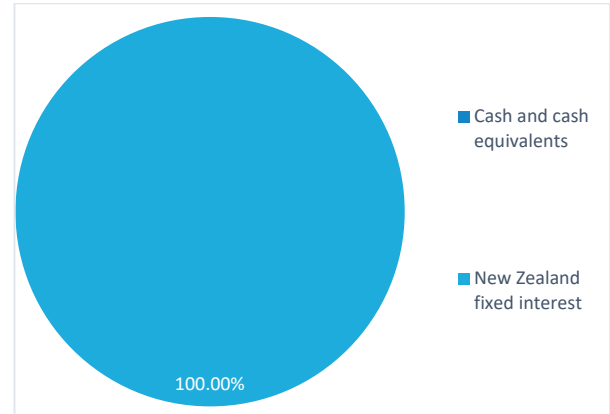
This shows the types of assets the Fund invests in.
